*Valid for installation dates on or after Jan. 1, 2023. Funds for incentives are limited and available on a first-come, first-served basis. Good/Better/Best options are defined based on equipment efficiency levels. Customers can upgrade more than one piece of equipment with different incentive levels. Premise eligibility is limited to single-family homes. Single-family homes are defined as 2 or fewer connected units. Each unit must be individually metered for natural gas and electric and each unit must have its own heating, cooling and water heating equipment.

†Air source and ground source heat pumps are eligible only for customers who are replacing an existing heat pump system and use electricity as the primary heating fuel. Ductless mini-split heat pumps are eligible for customers who are replacing a heat pump or electric resistance heating and use electricity as the primary heating fuel. All ductless mini-split heat pumps must meet the minimum requirement of HSPF 8.8 or 7.5 HSPF2 to be eligible for a rebate.
