

# **2024 HVAC PROGRAM UPDATES**

Starting Feb. 1, 2024, rebates for the DTE Energy residential HVAC measures will change.

Applications for 2023 installations will still receive the 2023 rebate amounts. These applications, however, must be submitted to the program no later than 20 days following installation.

Please review the eligibility requirements for the listed measures below.

#### Furnace Rebates

AFUE	95%	96%	97% or higher
Rebate Amount	\$100	\$200	\$400

**Customer Eligibility:** All residential DTE natural gas customers replacing an existing furnace.

#### Air Conditioning Rebates

SEER2	14.3 - 15.3	16.2-19.1	20.1+
Rebate Amount	\$100	\$200	\$300

**Customer Eligibility:** All residential DTE electric customers replacing an existing air-conditioning system.

### **Thermostat Rebates**

Thermostat Type	Wi-Fi Connected
Rebate	\$50

**Customer Eligibility:** All residential DTE natural gas or electric customers replacing a non-programmable thermostat. Thermostat must be connected to

an on-premise internet network.

#### **Heat Pump Rebates**

Air Source	14.3-15.19 SEER2; AHRI Rated	\$150
Air Source	15.2-16.99 SEER2; AHRI Rated	\$250
Air Source	17-17.99 SEER2; AHRI Rated	\$750
Air Source	18+ SEER2; AHRI Rated	\$850
Ground Source	16+ EER	\$800
Ductless Mini-Split	17+ SEER2; 7.5+ HSPF2 <i>(Both must be met)</i>	\$1,000

**Customer Eligibility:** Ground source heat pump and air source heat pump rebates are eligible for customers who are replacing an existing heat pump system and use electricity as the primary heating fuel. Ductless mini-split heat pumps are eligible for customers who are replacing an existing ductless mini-split or electric resistance heating.

### **Tune-Up Rebates**

Diagnostic Central AC Tune-Up	<ul> <li>Residential DTE electric customers</li> <li>CAC Tune-Ups on the same system are only eligible for one rebate every five years</li> </ul>	\$75
Diagnostic Furnace or Boiler Tune-Up (with combustion analysis)	<ul> <li>Residential DTE gas customers</li> <li>Furnace/Boiler Tune-Ups on the same system are only eligible for one rebate every two years</li> </ul>	\$75

Tankless Natural Gas Water Heater	UEF Rated; ENERGY STAR® Certified Model	\$100	Midstream Only
Storage Tank Natural Gas Water Heater	UEF Rated; ENERGY STAR Certified Model	\$50	Midstream Only
Heat Pump Water Heater	UEF > 2.2; Maximum Capacity of 55 Gallons	\$650	Midstream Only
Natural Gas Boiler	95% AFUE ARHI Rated or Higher	\$400	Midstream Only
Boiler ECM Circulator Pump	Hydronic Heating System	\$65	Midstream Only

Eligible water heaters must meet the following efficiency minimums to be eligible for the residential program: Natural Gas Storage Tank Water Heaters: 0.64 UEF, Natural Gas Tankless Water Heaters: 0.81 UEF, Heat Pump (Hybrid) Water Heaters: 2.2 UEF. Heat pump water heaters must replace an existing electric water heater.
